Do I Qualify for a Habitat for Humanity home?

NEED: You currently live in overcrowded, unsatisfactory conditions, or your rent is excessively high. Verifying annual income for all household wage earners falls within the income guidelines listed below:

ABILITY TO PAY:

- Verifiable, steady income for the past 12 months
- NO excessive credit card or multiple unresolved bills in collections, late bills, or late rent
- NO bankruptcy in the last 12 months
- Debt to Income ratio is less than 41%

WILLINGNESS TO PARTNER WITH HABITAT:

- Put in "sweat equity" by helping with your home, participating in homeowner education courses, volunteer for Habitat and our approved "sweat equity partners"
- Be able to pay a minimum of 1% of the sales price plus insurance and taxes at closing
- Be willing to be subject to a background check and consumer credit checks

RESIDENCY

- Be a US Citizen or Permanent Resident of the United States
- Live or work within Madison or Clark Counties for the last 12 consecutive months

How do I apply?

REQUIRED DOCUMENTS

YOUR COMPLETED APPLICATION MUST BE RECEIVED BY **OCTOBER 31, 2022** WITH THE FOLLOWING DOCUMENTS TO BE CONSIDERED OR PROCESSED:

- Copies of paystubs for the most recent 6 months for you and co-applicant(s)**
- Copies of other income verification**, such as: KTAP, Social Security, SSI/SSDI, disability benefits, alimony, pensions, product sales like Avon, child support, and any other income you receive. *Deposits into your checking account are not sufficient.*
- Copies of bankruptcy paperwork**
- Copies of divorce decrees for you and any co-applicant.** Divorce must be final before you apply
- Child custody papers**
- Copy of lease or canceled rent checks or receipts.**
- Copies of the last 3 months statements from all banks, credit unions, credit card copies, etc.** (including all pages)
- Copies of complete tax returns, including W-2s, for the last two years** - If you did not file tax returns, provide a signed and dated statement explaining why tax returns were not filed.

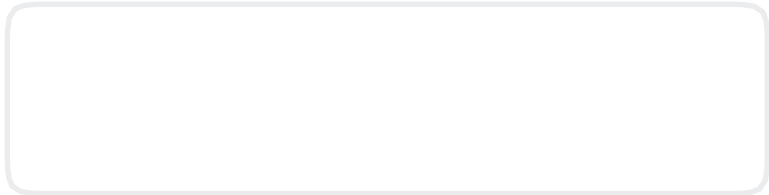
